#### **POSITION SUMMARY**

Bus Operator is responsible for safely and efficiently transporting seniors, people with disabilities, and general public in an NCAT vehicle in and around LaSalle County, Illinois. Operator will follow specified routes; arrive at pick up location, process fare payment, assist with loading/unloading passengers as needed, and drive passengers safely to their destination while maintaining predetermined time schedule.

#### PRINCIPAL DUTIES AND RESPONSIBILITIES

- Maintain positive, empathetic, and professional attitude towards customers and coworkers at all times; excellent customer service.
- Safely and efficiently provide transportation services for seniors, people with disabilities, and general public.
- Access route information using tablet and web-based scheduling and dispatch software.
- Assist passengers on/off vehicles, including assisting passengers to/from the door; properly use lift; secure wheelchairs or other mobility devices to ensure safe travel.
- Collect and track (including the ability to add and subtract) fare payment, punch card, penalty fees, etc. when passengers enter the vehicle.
- Acknowledge and refer customer complaints; use accurate and appropriate judgement and decision making when speaking with upset passengers or public. Document incident as soon as possible.
- Follow all traffic laws and local, state, and federal transit policies and codes.
- Perform routine vehicle checks for safety and maintenance reports, pre-trip and post-trip inspections.

- Properly document daily vehicle inspection, manifests, passenger and/or vehicle incident forms.
- Communicate vehicle, route, or passenger issues to dispatch immediately.
- Present oneself in a neat and clean manner, wear NCAT apparel and identification badge at all times.
- Know the communities in LaSalle County.
- Maintain and clean interior of vehicle daily, exterior as needed.
- Required to wear hands free telephone technology to communicate with dispatch or admin
  offices.
- Know, adhere to, and enforce NCAT policies and procedures.
- Maintain confidentiality and follow HIPAA guidelines.
- Attend all required meetings and trainings; remain current on trainings and certifications.
- Must be available to cover for coworkers scheduled or unscheduled time off.
- Respond to and assist in emergency operations (including nights and weekends) as needed.
- Perform other related duties as assigned; training will be provided.

- Positive and energetic demeanor with a focus on providing exceptional customer service.
- Ability to safely operate motor vehicles; valid driver's license required, CDL with passenger endorsement preferred.
- Ability to communicate clearly and effectively with a variety of individuals through different channels.
- Professionalism and the ability to remain calm and problem solve in stressful or upsetting situations.
- Follow instructions and apply acquired knowledge in responding to inquiries and requests.
- Perform work, including documentation, with accuracy, speed, and attention to detail.
